ASSOCIATED BEST FIT MODEL? Y/N: Y - STRATIGRAPHY

ASSOCIATED BEST FIT MODEL NOTES: THREE-DIMENSIONAL STRATIGRAPHIC SUPERPOSITION NORMAL CHRONOLOGICAL (BOTTOM FIRST), AFFECTIVE OUTLIERS. PRODUCTION DATES CROSS-REFERENCED WITH ADVERT DATABASE. NON-CHRONOLOGICAL ITEMS BY PRODUCTION DATE WERE REVIEWED AND REPLACED BY OWNER ON A MULTI-DIMENSIONAL AXIS (FRONT TO BACK, TOP TO BOTTOM). SEE "NOTES".

CONCLUSIONS: INVENTORY SHOWS HIGH CORRELATION TO BEST FIT. THIS SUGGESTS IMPACTED CONTENT'S PLACEMENT IN THE CONTAINER IS FOLLOWED BY INACTIVITY. LOCATION OF IMPACTED ITEM IN SITE ALSO MATCHES OWNER'S TENDENCY TO STORE IMPACTED CONTENT INSTEAD OF REGULARLY INTERACT WITH THE IMPACTED ITEM, BASED ON COMMENT FROM WITNESS. THE CONTAINER IS STASIS LOCKED WHILE THE CONTAINER CONTAINS ANY IMPACTED CONTENT. BOTH THE BEST FIT MODEL AND THE STATIC PROPERTIES OF THE CONTAINER ARE INCONSISTENT WITH THE SITE OVERALL.

DESPITE SIGNIFICANT ACTIVITY AND BEST FIT, CAUSE OF ACTIVITY IS STILL INCONCLUSIVE. ACTIVITY AND VARIABLE TESTS SUGGEST POSSIBILITIES 1) OWNER HAS AFFECTIVE OVERRIDE THAT EFFECTS CONDITIONAL INTANGIBILITY ONTO OBJECT SYSTEM; OR 2) WITNESS HAS AFFECTIVE OVERRIDE THAT EFFECTS CONDITIONAL INTANGIBILITY ONTO OBJECT SYSTEM. VARIABLE TACTILE TESTS FROM WITNESS DID NOT CHANGE INTANGIBILITY EFFECTS OF IMPACTED CONTAINER OR CONTENTS (SEE SECTION 1E). THERE IS NO DISTINGUISHABLE DIFFERENCE BETWEEN VARIABLE TACTILE TESTS FROM OWNER AND VARIABLE TESTS FROM SECTION 1E.

RECOMMENDATION: ACTIVITY DOES NOT POSE IMMEDIATE DANGER TO WITNESS. IMPACTED ITEM CANNOT REMAIN AT SITE DUE TO ACTIVITY'S AFFECTIVE INFLUENCE ON WITNESS.

CURRENT STATUS: APPROVED FOR IMPACTED CONTAINER TO MAINTAIN CONTENTS. APPROVED FOR REMOVAL TO STORAGE SITE 5.

NOTES :

FROM "GENERAL TREND GLOSSARY" (CHERSEK, 2007, PG. 41): "WHEN MULTIPLE ITEMS ARE PLACED TOGETHER IN A CLEAR SEQUENCE AND THAT SEQUENCE IS BROKEN, THE MOST LIKELY EXPLANATION IS THAT THE ORIGINAL SEQUENCE IS DELIBERATE AND THE BREAK IS NOT. HOWEVER, WHEN MULTIPLE BREAKS APPEAR, WE CAN GENERALLY ASSUME EITHER THE BREAKS ARE DELIBERATE OR THE ORIGINAL SEQUENCE ITSELF IS NO LONGER RELEVANT TO THE DATA."

IBID. PG. 53: "AN AFFECTIVE OUTLIER OCCURS WHEN AN OWNER OF AN ITEM HAS SOME AFFECT TOWARDS THE ITEM THAT CHANGES SOME INESSENTIAL FEATURE OF THE ITEM, LIKE ITS RELATIVE LOCATION. THEY MAY HAVE POSITIVE AFFECT TOWARDS THE ITEM (HAPPINESS, NOSTALGIA, TACTILE COMFORT, AMONG A VARIETY OF 'PLEASANT' OTHERS) OR A NEGATIVE AFFECT TOWARDS IT (SADNESS, REGRET, TACTILE DISCOMFORT, DENIAL, DISMISSIVENESS, AMONG A VARIETY OF 'UNPLEASANT' OTHERS) ."
